1. Lahore Ring Road Authority intends to prequalify the well reputed and experienced Firms / Contractors for Maintenance of Lahore Ring Road in the following category:

2. All interested Firms are required to submit documentary evidence of following pre-requisites:-
- Valid Registration with Pakistan Engineering Council (PEC) for current year in the relevant field(s) of specialization.
 - Evidence of valid registration with C&W Department in relevant category minimum in category C-3 for the current year or in case if general relaxation has been issued by C&W Department, then for the previous year.
 - Valid legal entity of the Firm e.g. registration with Securities & Exchange Commission of Pakistan (SECP) or registered with Registrar of firms or Government owned Organizations etc.
 - Undertaking on Judicial Stamp Paper that firm was never blacklisted by any of the Govt. or semi Govt. organization.
 - Certificate from Income Tax Department.
3. A set of Pre-Qualification documents are immediately available in the office of Deputy Director Contracts, LRRR & the same may be obtained before the submission date of documents subject to payment of the cost of printing and provision of the document which is Rs. 1,000/- (non refundable) in the shape of Pay Order / Bank Draft in favour of Lahore Ring Road Authority.
4. A set of Pre-Qualification documents shall be completed in English language and should reach the office of LRRR with acknowledgement to the Deputy Director Contracts, LRRR by **February 07, 2020** during office hours.
5. Applicants will be required to submit undertaking on Judicial Paper confirming that information given is correct. In case of false information, the applicant will be liable to blacklisting under Clause 21 of the PPRA Rules 2014.
6. Firms will be informed about decision in due course.
